- Vendors are encouraged to dress the part and decorate their booth according to our "Texas" theme.
- Participants must attend a meeting (date TBD) with the health code inspector prior to the event to discuss health code rules. The meeting will also cover information on set-up and clean-up for the event.
- Your participation automatically enters you into the Golden Chef Award contest. This award is judged based on food, booth decor & team spirit. Only those providing food in their booth will be eligible for the golden chef award.
- Booths must be completely set up and ready to go by 3:30pm.
